2. The Second Congressional Commission on Education (EDCOM 2), in partnership with the Department of Education (DepEd) and the research organization IDinsight, is conducting a study to produce evidence-based findings in support of policy directions related to Republic Act No. 11650. The study also aims to gather data on the experiences and challenges of teachers in identifying learners with disabilities and in the use of Individualized Education Plans (IEPs).

3. This online survey will be administered to Special Needs Education (SNED) teachers and receiving teachers of learners with disabilities from the selected schools nationwide.

4. The survey will be conducted from July 7 to 20, 2025, and may be accessed through the following link: https://bit.ly/idi-iesurvey. Estimated completion time is approximately 30 minutes. School Heads are advised to ensure that the survey administration does not disrupt class sessions.

5. School Heads of the identified schools are requested to disseminate the survey link to a maximum of ten (10) teachers, in accordance with the following guidelines:

a. Five (5) SNED teachers – If the school has fewer than five SNED teachers, the link should be shared with all available SNED teachers.

b. Five (5) receiving teachers – These are teachers currently handling at least one learner with a disability in their class. If the number exceeds five, the School Head shall select only five based on alphabetical order of their last names. If fewer than five are available, all applicable teachers may be included.

6. A limited number of schools may be contacted separately for follow-up qualitative interviews. IDinsight will coordinate directly with those schools as necessary.
