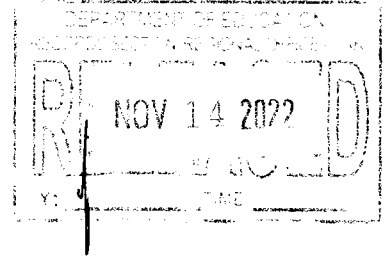

**2022 REGIONAL OBSERVANCE OF THE DEAF AWARENESS WEEK**

1. The Department of Education-Cordillera Administrative Region (DepEd-CAR) through the Curriculum and Learning Management Division (CLMD) will celebrate the **2022 Regional Observance of the Deaf Awareness Week** with the theme **DEAFusion: Bridging the Gap**. This is pursuant to Proclamation No. 829 dated November 8, 1991, entitled Declaring the Period from November 10-16 of Every Year as the Deaf Awareness Week.
2. The observance aims to raise awareness and consciousness on Deaf Culture and increase inclusion of Deaf people in the country.
3. The Office supports the observance of the said celebration by undertaking the following activities:
  - a. hanging of advocacy streamers in conspicuous places of schools or offices;
  - b. showcasing the capabilities or potential of Deaf learners;
  - c. conducting dialogue with parents and stakeholders on the theme of the Celebration;
  - d. discuss effective practices or approaches to better improve the inclusion of the Deaf in the classroom, school, and community; and
  - e. participation to activities organized by the Local Government Units (LGUs).
4. All activities shall be in accordance with DepEd Order No. 9, s. 2005 entitled Instituting Measures to increase Engaged Time-on-Task and Ensuring Compliance Therewith.
