**ADMINISTRATION OF THE RAPID MATH ASSESSMENT (RMA) AND
COMPREHENSIVE LITERACY ASSESSMENT (CRLA) FOR GRADES
1 TO 3 FOR THE BEGINNING OF THE SCHOOL YEAR 2024-2025**

- Relative to DepEd Memorandum Circular No. 2024-284, the Department of Education (DepEd) will conduct the nationwide administration of the **“Rapid Math Assessment (RMA) and Comprehensive Rapid Literacy Assessment (CRLA) for Grades 1 to 3 for the beginning of the school year 2024-2025, ensuring coverage across every public school in the country.**
- The results of these assessments shall be used to:
 - identify grade readiness and skills requiring improvements in reading and math skills.
 - assist teachers in the design intervention activities for this school year.
- The RMA and CRLA are scheduled for administration from **August 20 to September 20, 2024** and shall be administered as follows:
 - Grade 1 assessment tools to learners currently enrolled in Grade 1;
 - Grade 2 assessment tools to learners currently enrolled in Grade 2; and
 - Grade 3 assessment tools to learners currently enrolled in Grade 3.
- Teachers are requested to record learner results in the scoresheets provided. School heads shall ensure that the school summaries are promptly uploaded to the submission links provided as soon as all learners are assessed, **not later than September 20, 2024.**

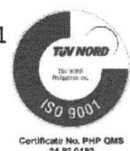


