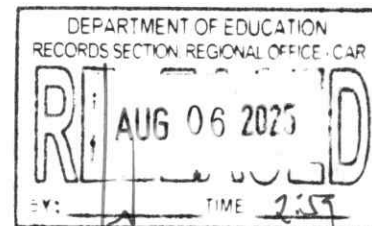

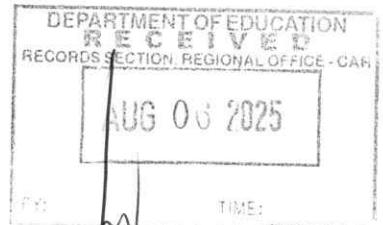

In reference to DM-OUHROD-2025-1870, please be informed that the **FY 2025 Refresher Training on the Implementation of Republic Act (RA) No. 11032 and the Launching of the RA 11032 Module on the Learning Management System (LMS)**, originally scheduled for July 25, 2025, has been **rescheduled to August 8, 2025**.
