

# ESTABLISHMENT OF A REGIONAL REPOSITORY OF SCHOOL SITES OWNERSHIP AND TITLING DOCUMENTS

To: Schools Division Superintendents
Division Legal Officers
Division Technical Assistants for School Sites

- 1. In line with the Department of Education's continuing efforts to ensure that public school sites are secured, protected, and legally recognized, the DepEd Cordillera Administrative Region will establish a **Regional Repository of School Site Ownership and Titling Documents**. Accordingly, the Technical Assistants for School Sites of the Province Division Offices are hereby directed to submit a **weekly report** on the number of validated school sites in their respective division offices.
- 2. In this regard, all Technical Assistant IV of Province Division Offices are instructed to:
  - a. Submit a weekly report on the data on the number of validated school sites. (See: Annex A. Data on the Number of Validated School Sites)
  - b. Provide weekly update on the Regional School Sites Titling Database through this link https://tinyurl.com/CAR-School-Sites-Titling.
  - c. Submit the report every Friday at 3:00 PM, addressed to the Regional School Sites Focal Person, via email at <a href="mailto:christopher.laoe@deped.gov.ph">christopher.laoe@deped.gov.ph</a>.
