Qualification Standards of Mentors and Program Facilitators

General:

- 1. Demonstrate excellent communication, facilitation, and mentoring skills;
- 2. Has a strong commitment to support the professional development of new teachers/ school heads;
- Willing to undergo orientation and participate in all program activities, as needed; and,
- 4. Endorsed by the Regional Director, or authorized representative.

Public Schools District Supervisors (PSDS):

- 1. Currently holding a Plantilla position of a PSDS and serving as PSDS;
- 2. Must have previously served as a full-fledged school head position, with at least 3 yrs. of experience in that role;
- Rated outstanding, with substantial contribution to instructional leadership and/ or school management;
- 4. With proven exceptional track record in mentoring or coaching experience at the school or district level; and
- 5. Willing to participate in the training of coaches and mentors and be part of the NEAP faculty as a trainer.

School Heads:

- 1. Currently serving as a school head (Principal 2, 3 or 4);
- 2. Has at least 10 yrs. of experience as a full-fledge school head;
- 3. With proven track record in school leadership, instructional supervision, and school-based mentoring; and
- 4. Willing to participate in the training of coaches and mentors and to be part of the NEAP faculty as a trainer.

Head Teachers or Master Teachers:

- 1. Has at least 3 yrs. of experience as an HT /MT;
- With proven track record in school leadership/ instructional supervision/ /school-based mentoring; and,
- Willing to participate in the training of coaches and mentors and to be part of the NEAP faculty as a trainer.
