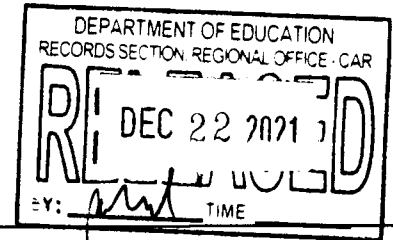

1. The Department of Education with its issuance of DepEd Order No. 01, s. 2020ⁱ, and DepEd Order No. 11, s. 2019ⁱⁱ highlights the ecosystem approach involving relevant internal and external stakeholders in the development and implementation of programs and courses whether as expert consultants, resource persons, learning facilitators or Learning Service Providers.
2. With NEAP transformation amid the effects of the COVID 19 pandemic, the necessity to address the emerging needs from the identified priority needs is coupled with the requisite for intervention to reskill and develop internal personnel to serve as learning service providers, learning facilitators, resource persons and consultants.
3. The purpose of this Project shall enable the participants to:
 - a. address the personal and professional growth and development of teachers and school leaders through orientation on recognition, authorization, and accreditation of professional development programs;
 - b. develop recognized professional development programs that would address the continuing professional development programs vis-à-vis the professional standards of teachers, school heads, supervisors, and non-teaching personnel;

The Schools Division Office shall identify the following participants to form the pool of Learning Service Provider content experts and training facilitators to participate in the Phases 1 and 2 of the Project. The Phase 1 shall be purely online scheduled on December 22-23, 2021, while the Phase 2 will be on a limited face to face training seminar scheduled December 27-29, 2021.
