

# COMPLETION OF SURVEY FOR IMPLEMENTERS OF THE STRENGTHENED SENIOR HIGH SCHOOL PROGRAM

To: Assistant Regional Director Schools Division Superintendents All Others Concerned

- 1. In reference to DepEd Memorandum issued by the Office of the Secretary dated August 30, 2025, this Office, through the Curriculum and Learning Management Division (CLMD), requests all Schools Division Offices (SDOs) to complete the Initial Survey for Implementers of the Strengthened Senior High School Program (SSHS).
- 2. The survey aims to gather insights into the experiences of school heads, teachers, parents/guardians, and learners during the first quarter of the pilot implementation of the SSHS Program.
- 3. In view of the above, all Schools Division Offices (SDOs) are requested to identify the respondents and facilitate the completion of the survey form.
- 4. The following are requested to respond to this survey:
  - a. All school heads of SSHS pilot school;
  - b. Five (5) teachers handling grade 11 learners and implementing the SSHS for each pilot school;
  - c. Five (5) parents or guardians of Grade 11 learners in the SSHS for each pilot school (Note: The parent or guardian-respondents should not be related to any of the learner-respondents, and should not be an employee of the school.); and,
  - d. Five (5) Grade 11 SSHS learners for each pilot school (Note: The learner should not be related to any of the parent-respondents of the same survey or with any employee of the school.
- 5. Parental consent forms must be completed and signed by parents or guardians before learners participate in the survey. A scanned copy or photo of the completed form must be uploaded through the Google Form survey provided. Please refer to the enclosed Annex A for the parental consent template.
