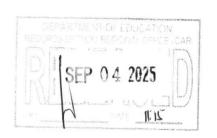

ORIENTATION ON THE REVISED DEPED ORDER ON THE RESULTS-BASED PERFORMANCE MANAGEMENT SYSTEM (RPMS) GUIDELINES FOR APPROVING AUTHORITIES

Pursuant to DM-OUHROD-2025-2424 titled "Orientation on the Revised DepEd Order (DO) on the Results-based Performance Management (RPMS) Guidelines for Approving Authorities", stating the Departments' commitment to strengthen its Performance Management and Evaluation System (PMES) and to support the attainment of Civil Service Commission (CSC) Program to Institutionalize Meritocracy and Excellence in Human Resource Management (PRIME-HRM), the Bureau of Human Resource and Organizational Development (BHROD) through the Human Resource Development Division (HRDD) will conduct a series of Orientation-Training sessions as follows:
