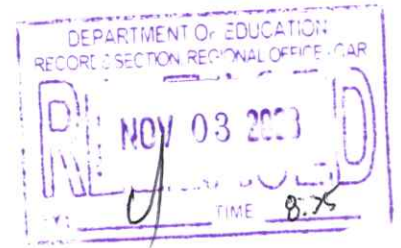

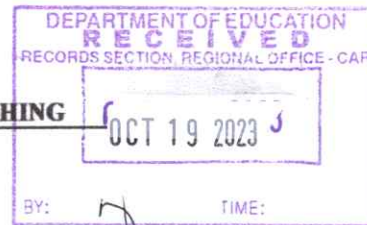

Assessment is an integral part of the teaching and learning process. It is a process of identifying, gathering and interpreting information about a student's learning. To objectively measure basic education learner's reading performance in the Philippines, the Department of Education issued DepEd Order No. 14, s. 2018 titled "Implementation Guidelines on the Administration of the Revised Philippine Informal Reading Inventory (PHIL-IRI)."

Phil-IRI is a classroom-based reading assessment tool used to measure and describe students' reading performance, which informs teachers in designing and providing appropriate reading instruction for their learners. This diagnostic approach to describing how children read embraces inclusionary practices that emphasize the need for education that is learner-oriented, responsive, and culturally sensitive.

In this regard, this Office requests your Region/Division to submit the five-year Phil-IRI results of your schools. The Department will use the data in the implementation of the Tara, Basa Program.
