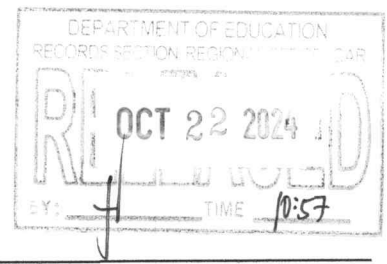

CONDUCT OF THE SCHOOL-BASED FEEDING PROGRAM MILK AND NUTRITIOUS FOOD PRODUCTS SUPPLIERS' FORUM

1. Relative to OM-OUOPS-2024-09-08376, the Office of the Undersecretary and Assistant Secretary for Operations through the Bureau of Learner Support Services-School Health Division will conduct the **School-Based Feeding Program (SBFP) Milk and Nutritious Food Products (NFP) Suppliers' Forum** on November 5-7, 2024 in Quezon City.
