CONDUCT OF LEADING WITH HOPE CLUSTER 3, SERIES 4: REGIONAL TRAINING OF TRAINERS (RTOT) FOR THE DEPED CAR PROJECT CHILD RIGHTS

To: Schools Division Superintendents All Other Concerned All Divisions

1. Pursuant to DepEd Order No. 040, s. 2020, this Office through the Human Resource Development Division (HRDD)-National Educators Academy of the Philippines in the Region (NEAPR) shall conduct Series 4: **RTOT for DepEd CAR Project CHILD (Committed and Holistic Integration of Learner's Development) Rights** on **August 16-18, 2023** at a venue to be announced later.
